

# PRIVACY & COOKIE POLICY

## I – INFORMATION ON THE SITE'S PRIVACY POLICY

1. This Privacy Policy describes how the site is managed with regard to the processing of personal data of users/visitors accessing and/or consulting it.
2. This information is also provided pursuant to Article 13 of Legislative Decree 196/03 and subsequent amendments and additions, the "Personal Data Protection Code", to those who interact with the web services of Wakala S.r.l.s., which can be accessed electronically from the address <http://www.wakala.it>, corresponding to the home page of the company's institutional website.
3. The information is provided only for the above-mentioned website and not for any other websites that may be consulted by the user/visitor via links.

## II – DATA PROCESSING

1. For the purposes of accessing this site and/or consulting it, data relating to identified or identifiable natural persons may be processed..
2. The 'Data Controller' of their processing is Wakala S.r.l., with registered office in Via Bartolomeo Cavaceppi, 113 - 00127 Rome.
3. The user/visitor is invited to read this Privacy Policy carefully before submitting any personal data/information and/or filling in any electronic form on the site.
4. Processing related to the web services of this site takes place at the aforementioned premises of Wakala S.r.l.s. No data deriving from the web service is communicated or disseminated.

## III – METHODS OF DATA PROCESSING

1. Personal data are processed by automated means (e.g. using electronic procedures and media) and/or manually (e.g. on paper) for the time strictly necessary to achieve the purposes for which they were collected. Specific security measures are observed to prevent the loss of data, unlawful or incorrect use and unauthorised access.

### BROWSING DATA

1. The computer systems and software procedures used to operate this website acquire, during their normal operation, some personal data whose transmission is implicit in the use of Internet communication protocols. This information is not, by its very nature, collected in order to be associated with identified interested parties, but by its very nature could, through processing and association with data held by third parties, make it possible to identify users/visitors (e.g. IP addresses, the domain names of the computers used by users/visitors connecting to the site, the URI - Uniform Resource Identifier - notation addresses of the resources requested). This data is

used for the sole purpose of obtaining anonymous statistical information on the use of the site and to check its correct operation, and is deleted immediately after processing.

2. The data could be used to ascertain liability in the event of hypothetical computer crimes against the site: except in this case, at present, data on web contacts do not persist for more than seven days.

## **DATA PROVIDED VOLUNTARILY BY THE USER/VISITOR**

1. The optional, explicit and voluntary sending by the user/visitor of personal data (e.g. e-mail) to the addresses indicated on this site entails the subsequent acquisition of the sender's data, which are necessary to respond to the requests made and/or to provide the service requested.

## **SOCIAL NETWORK PLUGINS**

1. This site also incorporates plugins and/or buttons for social networks, in order to allow easy sharing of content on your favourite social networks. These plugins are programmed in such a way as not to set any cookies when you access the page, in order to safeguard your privacy. Cookies are only set, if so provided by the social networks, when the user makes actual and voluntary use of the plugin. Please note that if the user browses while logged in to the social network then he or she has already consented to the use of cookies conveyed through this site at the time of registration with the social network.
2. 2. The collection and use of information obtained by means of the plugin is governed by the respective privacy policies of the social networks, to which please refer.

## **IV – USERS' RIGHTS**

1. The subjects to whom the personal data refer have the right at any time to obtain confirmation of the existence or non-existence of such data and to be informed of their content and origin, to verify their accuracy or to request that they be supplemented or updated, or corrected (Art. 7 of Legislative Decree 196/03 and subsequent amendments and additions).
2. Pursuant to the same article, data subjects have the right to request the deletion, transformation into anonymous form or blocking of data processed in breach of the law, as well as to object in any case, for legitimate reasons, to their processing. Requests should be addressed to the Data Controller, at the above address.

## **V – COOKIES**

1. Cookies are not used to transmit information of a personal nature.
2. Persistent cookies of any kind, i.e. systems for tracking users/visitors, are not used. The use of so-called session cookies (which are not stored persistently on the user/visitor's computer and are deleted when the browser is closed) is strictly limited to the transmission of session identifiers (consisting of random numbers generated by the server) necessary to enable the safe and efficient exploration of the site.



3. The session cookies used on this site avoid the use of other computer techniques potentially prejudicial to the confidentiality of user/visitor navigation and do not allow the acquisition of personal data identifying the user/visitor.
4. Users/visitors can set their computer browser to accept/reject all cookies or to display a warning whenever a cookie is proposed, so that they can assess whether or not to accept it.
